**MEDICAL INSURANCE:**

We try to provide the best medical coverage possible in case of need chas v'shalom. **It is compulsory for every student to be signed up with the Aim Medical Insurance. No girl will be allowed into dormitory without Aim coverage.** You will be receiving a package directly from them. Please respond in a timely manner.

**DRESS CODE:**

Our chosen Tehilas Bais Yaakov Talmidos are dignified who are pursuing an agenda of maturity and growth. For the sake of **clarity** and **convenience**, below are the following **distinctions**.

- **Skirts**- standard uniform fabric, pleated, a *halachically* permissible length (sufficient knee coverage at all times), of blue or black (no lycra, stretch fabric permitted)
- **Shirts**- button-down, long-sleeved shirt with a collar in a solid, light color only. Please include a white shirt for n"ר and special occasions.
- **Sweaters**- Black, navy, or gray solid sweater, or sleeveless vest.
- **Hair**- Groomed in a ponytail at all times.

**Technology Policies:**

**A. Devices:** Only MP3 players and recording devices without screens and internet capabilities are allowed. Any other device (IPod, IPad, MP4, Laptop, etc.) which has a screen for viewing and internet or email connections, **even if those capabilities were removed, is not allowed.**

**B. CELL PHONES:** One can only have in their possession a kosher phone from the Tehilas Bais Yaakov seminary provider with the **מואושר** symbol from the **ועד הרבנים** of **ארץ ישראל**. If you had a **sister in Tehilas Bais Yaakov**, and would like to use her phone, you must be in touch with our phone provider. You will be receiving a mailing packet in the summer directly from our provider.

**C. EMAIL** – Tehilas Bais Yaakov provides an option for email accounts for students. Only this email account is allowed.



## **CONSENT AND RELEASE**

1. With my consent and approval, the Student has applied to study at Tehilas Bais Yaakov – Jerusalem (the "Seminary") in the upcoming academic year.
2. I am aware that the Student shall be entitled to withdraw her registration with the Seminary by delivering written notice to the Seminary no later than April 1<sup>st</sup>, 2026 and, in the event of such withdrawal, any registration fee shall be refunded after deduction of the non-refundable deposit of \$7,900. After such date, no amounts shall be refunded and any deferred payments shall be collected on their due dates.
3. **I HEREBY ACKNOWLEDGE AND DECLARE THAT THE STUDENT, IF ACCEPTED, SHALL BE RESPONSIBLE TO COMPLY WITH ALL REGULATIONS AND STANDARDS OF CONDUCT ESTABLISHED BY YOU FROM TIME TO TIME.** I am aware that any failure to comply with said regulations and standards (including timely payment of tuition) may lead to the Student being required to leave the Seminary or continue her studies subject to restrictions. In the event of termination of the Student's participation in the Seminary program, I shall be solely responsible for arranging for the Student's return home and neither I nor the Student shall be entitled to any compensation and/or refund of fees or other payments made in relation to her participation in the Seminary program.
4. I hereby confirm that the Student has been examined by a suitably qualified physician who has been presented with all relevant information concerning the Student's medical history and proposed participation in the Seminary program. Said physician has confirmed that the Student is in good health and that there is no reason to believe that the Student should not participate in the program and/or travel overseas. The Student does not suffer from any physical, emotional or mental condition. Withholding any information from the seminary regarding physical, emotional or mental conditions of the Student could be grounds for dismissal.
5. I hereby authorize and direct the Seminary and its' authorized representatives to procure for the Student any medical or other assistance that may be required. In case of what the SEMINARY deems medical necessity, i.e. hospital care, and or serious medical care beyond the normal care the seminary can offer, the seminary has a right to require parental assistance, that is, expect the parents to come in from abroad to take care of the student. All of this is in case there is no family assistance and/or family support available in Eretz Yisroel.
6. I hereby agree to hold the Seminary, its' directors, agents, employees and assigns harmless from any liability or other obligation for any loss or other damage to any personal property of the Student or from other liability arising from the Seminary's acting in accordance with the above provisions.
7. I acknowledge that I have had the opportunity to receive advice regarding the contents of this document and fully understand its' provisions and implications. I am aware that the Seminary is only prepared to consider the Student's application in reliance upon my declarations and undertakings in this Consent and Release.

## TTI College Partnerships

To access these programs students must completed a FAFSA application and then join TTI.

Students will enroll in either **Daemen University** (US Citizens residing outside of New Jersey) or in **Pillar College** (New Jersey Residents).

Students are committing to earn a Bachelor Degree and are obligated to pay the relevant college tuition.

Students can apply for FAFSA to determine Financial Aid Eligibility. Federal and State Grants (NY/NJ), are available to offset College Tuition.

### **Daemen University:**

Financial Aid received by Daemen for the Fall and Spring Semesters occurring in Seminary is applied towards the student's seminary tuition balance. Students are responsible for any additional tuition owed to Daemen University.

### **Pillar College:**

**Participating students will receive up to \$17,000 scholarship towards their seminary tuition.** Students are responsible for any additional tuition owed to Pillar College.

Participation in TTI Seminary Study programs is contingent upon adhering to all-college policies and completing all requirements within the appropriate time frame. (This includes FAFSA applications for both years, NYTAP/NJFAMS and/or verification if relevant.) Students who drop out of the program or fail to settle college balances may lose all or part of their benefit of participation in the Program and will be responsible for paying the balance of their seminary tuition. Please note your adjusted tuition rate is contingent on meeting all your college obligations.

I understand that if my daughter fails to comply with and complete relevant academic and/or financial obligations, my daughter will be dropped from the Seminary Study Program and I will be responsible to pay the full Seminary tuition and dorm costs.
